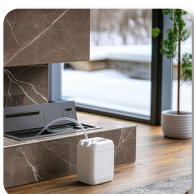
### SIMPLIFIED INSTALLATION

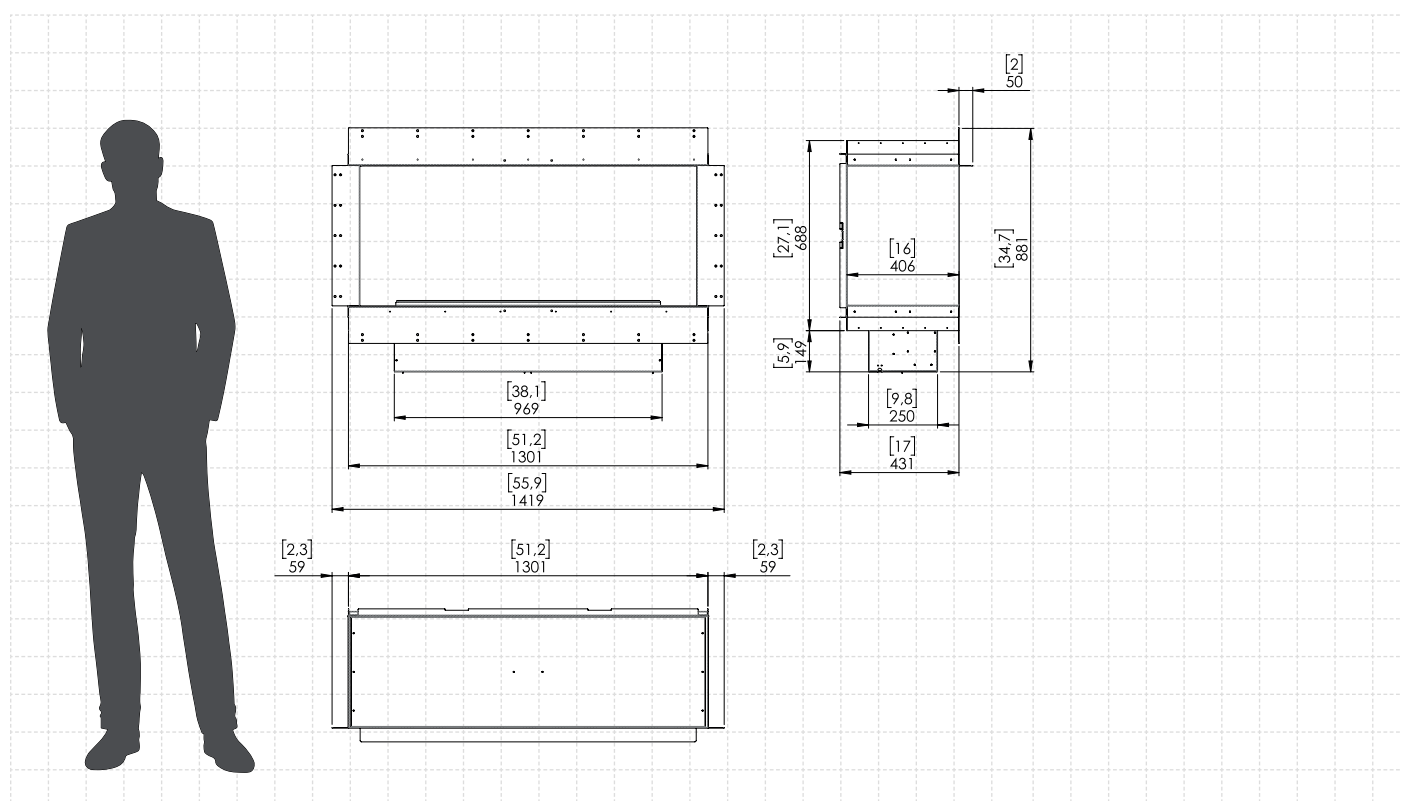
